	McMinnville Special Games is a local 501C3 organization that seeks to better the lives of disabled childr and adults through regularly scheduled events that provide structured interaction for disabled individuals						

and their care-givers. This culminates in the "Special Games" (Olympic themed event) held in May.

McMinnville Special Games started Horsin Around last year, a separate program dedicated to recreational equine therapy for the disabled children and adults with that they serve. Recreational equine therapy allows

the individuals to grow and develop through educational and recreational activities with horses. The program was a success, but now McMinnville Special Games wants to start pivoting Horsin Around towards a therapeutic program for adults and children. To make the transition and to make it a sustainable program, Horsin Around needs a mobile storage barn that can be set-up on donated, leased land to provide a space for the horse supplies (they received donated horses also) such as the saddles, tackle and food. This building will keep items safe from prowlers and keep the hay & feed dry. The grant is just the start to be able to start the therapeutic program and have a base of operations. To make the program sustainable, Horsin Around will have an adopt a horse program where individuals or businesses can adopt a horse for a year for \$500. The \$500 will be used to feed and maintain the health of the horse. Sponsors will also be able to provide care and love for the horses and to partner with some of the disabled children and adults to care for the horses. This is what a similar program in Franklin does and it has been successful there.

Rotarians will be involved with the purchase and installation of the mobile barn and shelving. They will help volunteer at Horsin Around events. Horsin Around events will grow from quarterly to monthly events. The land is under a one year renewable lease that is not expected to change. If for some reason the lease agreement is cancelled, the program will be able to continue on land owned by Rotarians until a new lease is found. Because the mobile barn is mobile, it will be able to be moved if need be. Horsin Around volunteers will be responsible for the care of the horses. Rotarians will help this first year of the grant. Several Rotarians are interested in supporting Horsin Around for years to come.

 This need was identified based on Horsin Around's experience with recreational equine therapy and the

interest and success of it. Many individuals were identified would benefit further with monthly equine therapy instead of just quarterly recreational therapy.

The target group is the approximately 100 disabled adults and 150 disabled children that participated in the quarterly Horsin Around/McMinnville Special Games events as well as their care-givers .

- A fundraising trail ride will be held in early April to help raise funds and increase public awareness of the importance of equestrian therapy.
- Purchase of the mobile barn for approximately \$6500 (this is a pre-fabricated barn)
- Installation of the mobile barn on the leased property
- Purchase of interior shelving for the mobile barn \$500
- Installation of the shelving
- Ongoing monthly therapeutic equestrian events
- Garner horse sponsors at \$500 each
- h. Project Outcomes and Impact Describe how the project will benefit the community and/or improve the lives of those impacted by the project:

Equine therapy, has been shown to be one of the best ways to engage disabled individuals and improve their motor skills, physical abilities and emotional interaction. Therapy has been shown to be most beneficial for those suffering from down syndrome, multiple sclerosis, cerebral palsy, brain and spinal cord injuries, attention deficit disorder, spina bifida and stroke related impairments. However, this project would be used for all interested disabled individuals, up to 250, that participate in McMinnville Special Games events.

A project team composed of President Elect Brent Foster, Treasurer Debbie Sain, Board Member Neal Cox and McMinnville Special Games President Holly McBride will review purchases and attempt to find the lowest cost items that suit the needs of the organization.

The mobile barn will need ongoing maintenance by the cooperating organization, Horsin Around, through the adopt a horse program described above and fundraising as needed.

The mobile barn should last approximately 20 years or more and provide a solid base from which to sponsor events from. Rotarians will be involved with the purchase and installation of the mobile barn and shelving. They will help volunteer at Horsin Around events. Horsin Around events will grow from quarterly events to monthly events. The land is under a one year renewable lease that is not expected to change. If for some reason the lease agreement is cancelled, the program will be able to continue on land owned by Rotarians until a new lease is found. Because the mobile barn is mobile, it will be able to be moved if need be. Horsin Around volunteers will be responsible for the care of the horses. Rotarians will help this first year of the grant. Several Rotarians are interested in supporting Horsin Around for years to come.

Grant Eligibility Guidelines

The mission of The Rotary Foundation is to enable Rotarians to advance world understanding, goodwill, and peace through the improvement of health, the support of education, and the alleviation of poverty. District Grants enable clubs and districts to address immediate needs in their communities and abroad. District grants are designed to give clubs flexibility to meet needs in their communities. The following is a basic list of guidelines. If you have questions contact your District Grants Committee.

Eligible

- Construction of wells, reservoirs, latrines, toilet blocks, water supplies and similar structures.
- Purchase of equipment or appliances for humanitarian purposes.
- Short term and/or contracted labor for project implementation.
- Primary and secondary education, tuition and transportation.
- Travel to develop a Global Grant and some Domestic travel.
- Publicity expenses such as newspaper fees, printing of posters, brochures or fliers to inform the community of an available service.
- Only fund activities that have been reviewed and approved by TRF before their implementation. Grants may not be used to
 reimburse clubs or districts for activities and expenses already completed or in progress. Planning for grant activities prior to
 approval is encouraged, but expenses may not be incurred. After grant approval, any changes to the original project plan must
 be pre-approved by TRF.
- · Budgeted and itemized humanitarian goods.
- Detailed, itemized expenses.
- Both community and international projects.

Ineligible

- Continuous or excessive support of one beneficiary, entity, or community.
- Establishment of a foundation, permanent trust or long term interest bearing account.
- Purchase of land or buildings
- Fundraising activities.
- Expenses related to Rotary events such as District conferences, conventions, institutes, anniversary celebrations, or entertainment activities.
- Public relations initiatives not directly related to a humanitarian or educational activity.
- Project signs in excess of \$ 500.
- Operating, administrative, or indirect program expense of another organization.
- Unrestricted cash donations to a beneficiary or cooperating organization.
- Activities for which the expense has already been incourred.
- Study at a Rotary Peace Centerpartner university in the same or similar academic program as those pursuing by Rotary Peace Fellows.

In addition, grants cannot be used to unfairly discriminate against any group; promote a particular political or religious viewpoint: support purely religious functions; support activities that involve abortion or that are undertaken solely for sex determination; fund the purchase of arms or ammunition; or serve as a new contribution to the Foundation or another Rotary Foundation grant.
